- Knowledge of sustainable development, integrated design processes, performance analysis and recognition of excellence (awards, grants, etc.) are assets.
- Adequate proficiency in the French language or a strong commitment to mastering the proficiency level required upon assuming the position in accordance to <u>Université de Montréal's Language Policy</u>.
